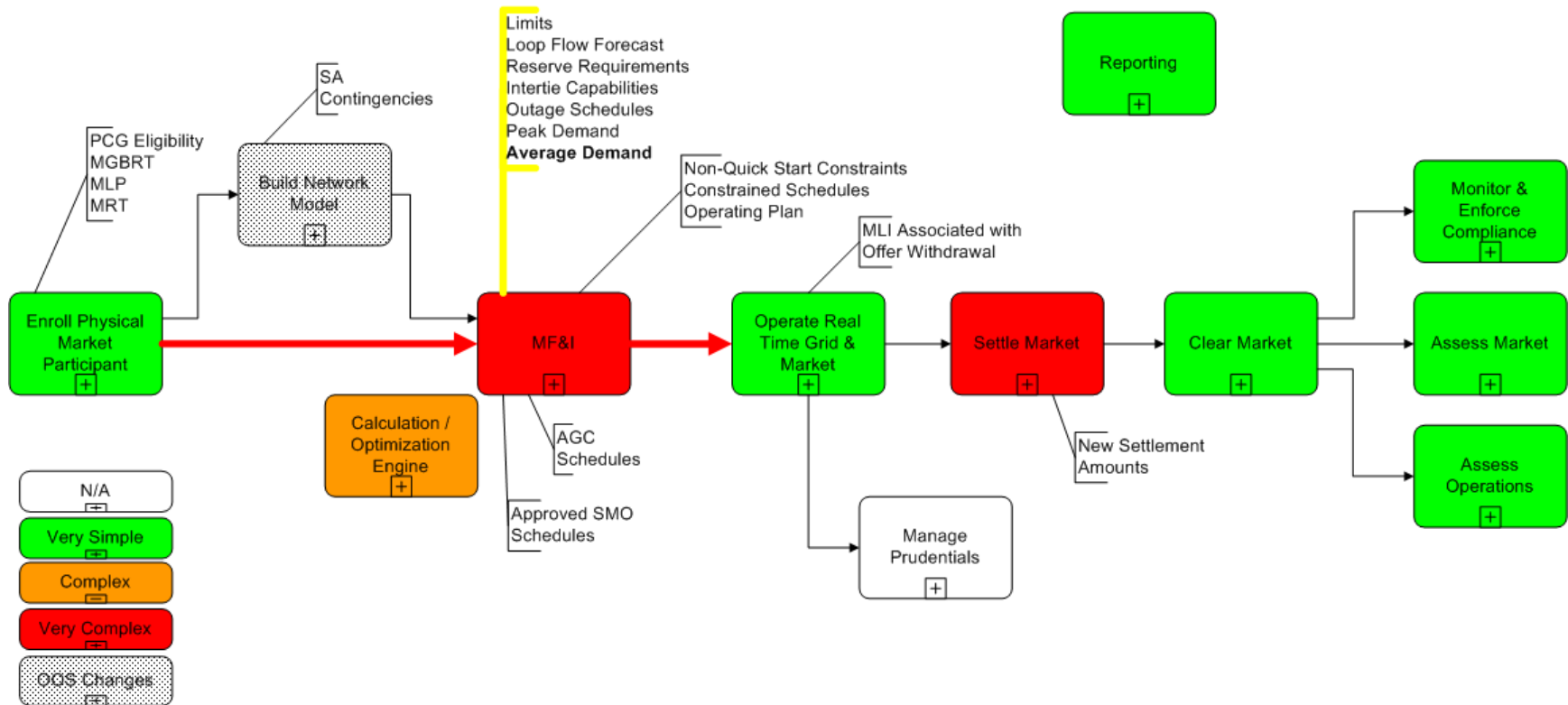

- While linkages between the functional areas exist, the Operations and Settlement stakeholdering needs differ slightly
 - Operations – Concentrates on Defining
 - Business Process impacts
 - User / Functional Impacts
 - Settlements – Concentrates on Understanding and Defining
 - Equations and Charge Type Implementation
 - Business Process impacts
 - User/Functional Impacts
